Arrangement of Electronic Dissemination of Corporate Communications

Pursuant to Rule 2.07A of the Rules Governing The Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) relating to the expansion of paperless listing regime, electronic dissemination of corporate communications came into effect on 31 December 2023. K. Wah International Holdings Limited (the “**Company**”) is writing to inform you that the Company shall accordingly in the future adopt electronic dissemination of its corporate communications (the “**Corporate Communications**”), thereby any documents issued or to be issued by the Company for the information or action of holders of any of the Company’s shares or securities or the investing public, including but not limited to (a) the directors’ report, its annual accounts together with a copy of the auditors’ report and, where applicable, its summary financial report; (b) the interim report and, where applicable, its summary interim report; (c) a notice of meeting; (d) a listing document; (e) a circular; and (f) a proxy form, shall be published electronically.

Please note that both the English and Chinese versions of all the future Corporate Communications will be available electronically on the website of the Company at www.kwh.com and the website of HKEXnews at www.hkexnews.hk, whereas a notification letter about the Corporate Communications will be distributed to you by email or by post (only if the Company does not have your functional email address) on the publication date of the Corporate Communications. You are encouraged to subscribe for the News Alert service on HKEX’s website, to receive instant notification of the Company’s Corporate Communications.

Notwithstanding the above, please note that actionable corporate communications as defined under the Listing Rules (the “**Actionable Corporate Communications**”) ^(Note 2) will be sent to you individually through email (or in printed form, only if the Company does not have your functional email address), in addition to having such information being made available electronically on the Company’s website and the HKEXnews website respectively.

Solicitation of electronic contact details

In order to ensure timely receipt of the Corporate Communications, in particular the Actionable Corporate Communications by you, the Company recommends you provide your email address by scanning your personalized QR code printed on the enclosed reply form (the “**Reply Form**”). Alternatively, you may sign and return the Reply Form to the Company’s Hong Kong branch share registrar (the “**Share Registrar**”), Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen’s Road East, Wan Chai, Hong Kong.

If the Company does not receive from you a functional email address in your reply, until such time that a functional email address is provided by you to the Share Registrar, (i) you may be unable to receive any notifications regarding the publication of the Corporate Communications by email; (ii) you will need to proactively check the Company’s website and the HKEXnews website to keep up with the publication of the Corporate Communications; and (iii) the Company will send the Actionable Corporate Communications to you in printed form in the future. If the Company does not receive the duly completed Reply Form from you, you will receive a printed notification letter by post, about the Corporate Communications published on the Company’s website and the HKEXnews website in the future.

If you would prefer to receive the Corporate Communications (including the Actionable Corporate Communications) in printed form, please complete the Reply Form and return it to the Share Registrar or send an email to kwah.ecom@computershare.com.hk specifying your name, address and request to receive the Corporate Communications in printed form. Please note that your instruction for receiving the Corporate Communications in printed form shall be valid for one year starting from the date of receipt of the Reply Form and it will expire thereafter.

以電子方式發布公司通訊之安排

根據有關擴大無紙化上市機制下香港聯合交易所有限公司證券上市規則（「**上市規則**」）第 2.07A 條規定，自 2023 年 12 月 31 日起，公司通訊必須以電子方式發布。嘉華國際集團有限公司（「**本公司**」）謹此通知閣下，本公司日後將相應採用以電子方式發布公司通訊（「**公司通訊**」）之安排，從而本公司發出或將予發出以供其任何股份或證券持有人或投資者參照或採取行動之任何文件，包括但不限於(a) 董事會報告、年度賬目連同核數師報告副本以及（如適用）其財務摘要報告；(b) 中期報告及（如適用）其中期摘要報告；(c) 會議通告；(d) 上市文件；(e) 通函；及 (f) 代表委任表格將以電子方式發布。
